

Immunization and Vaccination National Custom Data Elements

Custom Data Elements and Values are developed through collaboration with NEMSIS stakeholders. They are provided for States/Territories and EMS Software Vendors to support standardization and consistency in data collection. The ability to add elements and values that are not a part of the current National Data Standard is crucial in responding to the ever-changing environment of EMS.

While data documented in Custom Elements and Values are not sent to the National EMS Data Repository, they are valuable to States/Territories and Vendors in collecting and assessing new and emerging trends without having to implement a full new data standard.

Vaccination Custom Elements

Element	Title	Description
eMedications.901	Medication Dose Number	The dosing number for medications requiring a series of administrations.
eMedications.902	Medication Manufacturer	The pharmaceutical manufacturer of the medication administered.
eMedications.903	Medication Lot Number	The lot number of the medication administered.
eMedications.904	Medication Expiration Date	The expiration date of the medication administered.

*The code above is an "Ingredient" code used by both the Moderna and Pfizer vaccines and is recommended for EMS use by the NEMSIS TAC. If desired, the "Precise Ingredient" codes below can be used instead to differentiate between the two vaccines:

Moderna vaccine: 2470232 - SARS-CoV-2 (COVID-19) vaccine, mRNA-1273 Pfizer vaccine: 2468230 - SARS-CoV-2 (COVID-19) vaccine, mRNA-BNT162b2
